RENOUNCEABLE ENTITLEMENT OFFER

Incremental Oil and Gas Ltd (ASX: IOG) (**IOG**) confirms that its pro-rata renounceable entitlement offer announced on 30 October 2017 closed over-subscribed on Monday 20 November 2017. 51% of the entitlement that was offered was taken up by existing shareholders. The Board has agreed to place the balance of the unsubscribed shortfall to investors introduced by lead manager CPS Capital.

The total funds raised including the entitlement offer and placement to Mr McCann will be approximately \$2.04 million (before costs and subject to clearance of funds).

As announced on 21 November, subject to shareholder approval, a further 6,288,374 shares and 6,288,374 options will be issued to Non-Executive Director, Mr Matthew McCann, on the same terms and conditions as those issued in the entitlement offer.

The new shares and options under the entitlement offer (including the additional shares and options under the top-up facility) are expected to be issued on 24 November 2017 and to commence trading on a normal (T+2) settlement basis on 27 November 2017.
