We are writing to you as a registered holder of listed options ("Options", ASX code "E2EOA") in Eon NRG Limited ("Eon" or the "Company") to remind you that the Options will expire at **5:00pm (WST) on Monday 22 February 2021**.

Your Options holding may be exercised in whole or in part by payment of \$0.015 for each Option. If payment is not received by at 5:00pm (WST) on Monday 22 February 2021, the Options will lapse and all rights under the Options will cease at that time.

The courses of action available to you as a holder of these Options are:

## A. Exercise all or some of your Options

To exercise your Options, the enclosed Option Exercise Notice and your cleared funds must be received by the Company's share registry no later than 5:00pm (WST) on Monday 22 February 2021. Payment instructions are on enclosed form.

### B. Sell all or some of your Options on market

If you elect not to exercise your Options, you may wish to consider selling your Options.

### C. Do nothing and allow your Options to lapse

If you do not take any action to exercise your Options prior 5:00pm (WST) on Monday 22 February 2021, the Options will expire and your right to purchase shares at \$0.015 will lapse.

- 5. The latest available market price of Eon shares prior to the date of this notice was \$0.001 at the close of trading on 19 May 2020. Note that the Company's shares and options have been suspended from trading since this date.
