

Updated Notice of Expiry of Quoted Options

NOTICE OF EXPIRY OF LISTED OPTIONS

Voltaic Strategic Resources Limited (ASX:VSR) (“**Voltaic**’ or the ‘**Company**”) wishes to advise that you are a registered holder of listed options (ASX:VSRO)(“**Options**”) in the Company.

The Options are exercisable at \$0.08 each and expire at 5.00pm (AEST) on 30 June 2026 (“**Expiry Date**”). There is no obligation upon Option holders to exercise their Options. However, under paragraph 5.2 of Appendix 6A of the ASX Listing Rules, the Company is required to advise Option holders of the information contained in this notice.

The courses of action available to you as the holder of these soon-to-expire Options are:
