Expiry of Unlisted Options

Voltaic Strategic Resources Ltd ('Voltaic' or the 'Company') (ASX:VSR) wishes to advise that 196,274,167 unlisted options, exercisable at \$0.03 (Options) will expire at 5.00pm (WST) on Sunday, 5 October 2025 (Expiry Date).

In accordance with Clause 5.2 of the Appendix 6A of the Listing Rules, the Company provides the following information:

- The number of Options to which this notice applies are 196,274,167 and for every Option exercised, the holder of the Option will be issued one fully paid ordinary share ("Share").
- The exercise price of the Options is \$0.03 each.
- The due date for the payment of the exercise of the Options is 5 October 2025 ("Expiry Date"). Note that this date falls on a Sunday and so funds will need to be received by the Company by Friday 3rd October in order for the Options to be validly exercised.
- If the Options are not exercised and payment for the exercise of the Option is not received by the Expiry Date, the Options will automatically lapse, and all rights attached to the Options will cease.
- The last closing market price of the Shares (being the underlying securities to which the Options relate) was \$0.022 on 18 September 2025.
- During the three months immediately before the date of this notice:
 - The lowest market price of the Shares was \$0.011 per Share on various dates between
 June 2025 and 18 September 2025; and
 - The highest market price of the Shares was \$0.026 per Share on various dates between
 June 2025 and 18 September 2025;
 - o The exercise of the options is not underwritten.

The Company advises that options expiry notices will not be sent to the holders of the Options as the Options are substantially out of the money.
